Utah Sighthound Racing & Coursing Club Member Code of Conduct

- Members shall abide by the rules and regulations of the American Kennel Club Code of Sportsmanship, and/or the rules of any sanctioning organization under which an event is held.
- Consideration of other persons is imperative at all times - ie. on and off trial sites, meeting sites, social media websites, etc. A member will not engage in false or misleading statements directly or indirectly, regarding a judge, official, exhibitor, fellow member, another dog, or misrepresentation of their own dogs through claims or false or misleading advertising.
- Hotels, trial sites and show grounds shall be treated with respect and left in a clean condition. Unresolved complaints are cause for expulsion from the club.
- Education and communication are the preferred methods of obtaining compliance to this Code of Conduct; however, flagrant, serious and/or repeated disregard of this code may result in formal charges brought before the USRCC Board of Directors by club members or non-members up to and including revocation of membership and all rights thereof.

When interacting with others, I shall positively and professionally represent myself as a member of the Utah Sighthound Racing and Coursing Club (USRCC) and adhere to the stated goals of the USRCC, which are: to encourage and promote good sportsmanship in all events sanctioned by the club.
