Trial Hours:

Check-in for dogs belonging to the field committee will begin 30 minutes before published trial hours.

Monday, May 31st – “Day of” entries close at 8:00 am.

Roll Call at 8:15 am – Draw at 8:30 am with trial to start immediately after the draw.

Certification runs will be offered before the trial for dogs planning to enter this trial. Dogs not entering this trial may certify after the trial completes.

E-mail entries will be accepted, payment can be made via PayPal or Venmo for an additional \$2 fee per entry.

The handler presenting the certifying hound shall be responsible for providing the Testing Hound for the qualifying course.

Eligible Breeds:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneco dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Silken Windhound, Sloughis, Whippets, and Provisional breeds may be entered in the regular stakes. Current Provisional breeds include purebred Chart Polski, Galgo Español, Magyar Agar, Peruvian Inca Orchid, Portuguese Podengo (Pequeno), Portuguese Podengo (Medio & Grande), and must be individually registered with the appropriate registry.

All entries shall be individually registered with the AKC (including ILP & PAL), the NGA, the UKC, an ASFA-recognized foreign or ASFA Board approved registry, or possess a CRN from the SPDBS. A photocopy of acceptable registry must be submitted with each hound's first ASFA field trial entry; this requirement is waived for hounds registered with the NGA..

Stakes Offered:

OPEN STAKE – Open to Hounds who have met certification requirements. Excluded ASFA Field Champions of record.

FIELD CHAMPION STAKE – Any Hound ASFA Field Champion of record.

VETERAN STAKE – Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Rhodesian Ridgebacks, Salukis and Whippets whose age shall be at least seven years that have met certification requirements. Points go toward V-FCh or V-LCM.

SINGLE STAKE – Any eligible sighthound including those disqualified to run in other stakes. Each hound runs alone. Not eligible for Best of Breed or Best in Field. Hounds are eligible to earn TCP and CPS titles from the Singles stake. Provisional breeds are not eligible for these titles.

PROVISIONAL STAKE – Any eligible sighthound of a Provisional breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

BEST IN FIELD – Will be offered

Any exhibitor or participant who shows any sign of illness prior to or during the event will be asked to leave the trial site, and their entry fees will be refunded in full. Any exhibitor or participant unable or unwilling to adhere to the safety guidelines will be asked to leave the trial site.

Conditions of Entry:

Hounds must be one year or older on the day of the trial. All hounds will run twice, in trios if possible or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at the time of roll call will be scratched after a five-minute grace period. Each entry will be examined at inspection for breed disqualifications. Hounds determined to have a breed disqualification at the time of roll call shall be barred from competition and their entry fees shall be refunded. Spayed, monorchid, cryptorchid, and neutered hounds without breed disqualifications may be entered. Regular stakes will be split if 20 or more entries are present in any one stake at the time of the draw. Any hound that displays aggressive behavior during trial hours will be excused for the day. A penalty of \$5 will be assessed for any loose hound not competing in the course in progress.

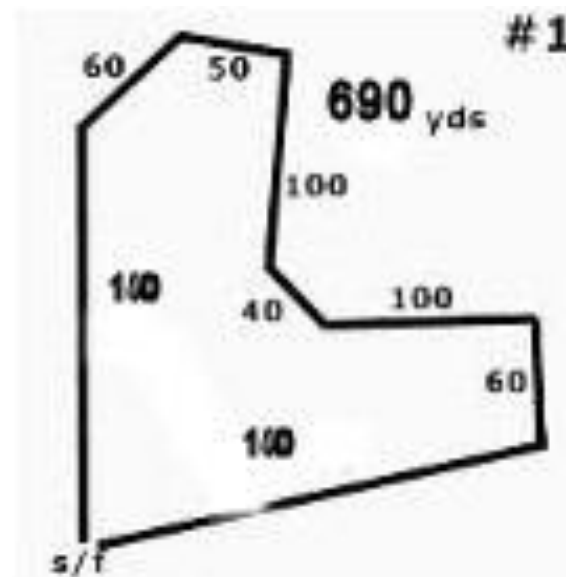

Equipment & Field Information:

Terrain is mowed grass polo field. Hounds need to be in top physical condition due to the high elevation. Battery powered continuous loop machine will be used and backup equipment will be available. Lure will consist of white and/or black plastic strips.

Course Plan:

The course is 690 yards, reversed for finals, BOB direction at the discretion of the judges. USRCC reserves the right to change the course design to maintain safety or to accommodate field conditions.



General Information:

There are restrooms on site. Bring your own food, water and shade. No littering. Pick up after your dogs, and please haul your garbage off the field. There will be a fine for NOT leaving the field as you found it. RV parking is available, electrical hookups are available for \$20-\$30 per night depending on amperage.

USRCC welcomes spectators, but asks that all spectators and exhibitors adhere to ASFA and USRCC standards of conduct. Any spectator or exhibitor that behaves in an inappropriate manner will be asked to leave the trial site.
